**APPLICATION FOR ACCREDITATION OF REINSURANCE COMPANY FOR THE  
YEAR 2026**

**Date: November 14, 2025**

The application for accreditation for the year 2026 is to be made through TIRA Online Registration System (ORS) that is accessible through <https://ors.tira.go.tz/#/>. (Guideline on submission of documents is hereby attached).

All foreign reinsurers seeking to transact insurance business with Tanzanian insurance market must earn an Accreditation Clearance Letter from TIRA which will be issued to successful applicants only.

The following information shall be filed in the TIRA ORS;

1. Payment of fees:
  - i. Non-refundable application fee of USD 1,000; and
  - ii. Accreditation fee USD 9,000.
2. Copies of Certificate of incorporation from Home jurisdiction from the Registrar of Companies.
3. Copy of active license issued by insurance Regulator in home jurisdiction.
4. Credit rating by a reputable rating agency.
5. Audited financial statements for the previous 3 years.
6. Letter of good standing From the Regulatory Authority in the applicant's home jurisdiction, confirming that the license is active and free of compliance issues. The Letter must be translated into clear Swahili or English language.
7. Bank details of the applicant's collection account for the accreditation purposes, which must be maintained with a bank located in applicant's home jurisdiction including:
  - i. Beneficiary name;
  - ii. Beneficiary account number;
  - iii. Bank name; and
  - iv. Bank swift code.

8. List of Shareholders of the company and their respective passports.
9. Details of the board members, including:
  - i. Name of each board member;
  - ii. Date of appointment; and
  - iii. Passport of each Board member.
10. Recommendation letters from at least one (1) locally registered entity, either an Insurance Company, Reinsurance broker or a Reinsurance Company operating in Tanzania.
11. Any other additional information as may be required by the Authority.

**NB:**

- i. All documents should be certified by a dully Authorized Notary Advocate.
- ii. The Authority shall receive a net amount of USD 10,000. Any bank charges, transfer fees, taxes, or other associated costs shall be borne exclusively by the Applicant.
