A CIRCULAR TO ALL ASSESSORS, SURVEYORS AND LOSS ADJUSTERS

#### ANNUAL MAINTENANCE REQUIREMENTS FOR THE YEAR 2024

Pursuant to Insurance Act (Cap394) which governs the issuance of registration; you are required to file in each calendar year before 30th November all necessary documents for the maintenance of your registration status during that year and make all payments as provided in the Third Schedule to the Insurance Regulations GN 372 of 2009.

The filing of annual maintenance documents for the year 2023 shall be made not later than 30th November, 2023 through the TIRA Online Registration System (ORS) that is accessible through https://ors.tira.go.tz/#/. (Guideline on submission of documents is hereby attached).

The filing of documents shall be made upon payment of an application fee of Tshs. 25,000/= (Twenty-five thousand) and payment of Annual Fee of Tshs. 100,000/= (One Hundred thousand) shall be paid for Loss assessors, surveyors, and Adjusters.

All Payments must be deposited through Government Electronic Payment Gateway (GePG), the control number shall be generated through TIRA Online Registration System (ORS).

All registrants shall furnish the Authority with the following documents;

- Copy of renewed FDR of Tshs. 2.0 million (Minimum) Regulation No.18 (6) for loss Assessors, Surveyors, Loss Adjusters.
  - For the purpose of FDR please attach a dully filled Annexure 1 provided hereto within TIRA ORS.
- Copy of professional Indemnity cover-note for assessors, Surveyors and Loss Adjusters is of Tshs. 12,000,000/- minimum Sum Insured.

### ANNUAL MAINTENANCE REQUIREMENTS FOR THE YEAR 2024

The filing of documents shall be made upon payment of an application fee of Tshs. 25,000/= (Twenty-five thousand) and payment of Annual Fee of Tshs. 100,000/= (One Hundred thousand) shall be paid for Loss assessors, surveyors, and Adjusters.

All Payments must be deposited through Government Electronic Payment Gateway (GePG), the control number shall be generated through TIRA Online Registration System (ORS).

All registrants shall furnish the Authority with the following documents;

- Copy of renewed FDR of Tshs. 2.0 million (Minimum) Regulation No.18 (6) for loss Assessors, Surveyors, Loss Adjusters.
  - For the purpose of FDR please attach a dully filled Annexure 1 provided hereto within TIRA ORS.
- Copy of professional Indemnity cover-note for assessors, Surveyors and Loss Adjusters is of Tshs. 12,000,000/- minimum Sum Insured.

iii. A letter from Association of Tanzania Loss Adjusters and Surveyors (ATLAS)

confirming your active membership.

iv. Information on your current Principal Officer including

a) CV;

b) Professional qualifications certificates as per regulation 14;

c) Copy of academic certificates verified by TCU/NACTVET (for foreign

certificates);

d) Employment contract/Copy of engagement letter attested by the intended

candidate;

e) Attested declaration on solvency and non-conviction in criminal offences;

and

f) Copy of NIDA/ Passport for non-citizen.

The last date for filing annual maintenance documents is 30th November 2023.

A penalty amounting to Tsh. 10,000/= per day (Ten thousand shillings) and not exceeding Tsh.1,000,000/= (One million) would be imposed for late filing,

incomplete and non-submission of annual maintenance documents.

Every registrant MUST pay all outstanding penalties which have been imposed

by the Authority for the previous year.




