ANNUAL MAINTENANCE REQUIREMENTS FOR THE YEAR 2024

Pursuant to Insurance Act (Cap394) which governs the issuance of registration; you are required to file in each calendar year before 30th November all necessary documents for the maintenance of your registration status during that year and make all payments as provided in the Third Schedule to the Insurance Regulations GN 372 of 2009.

The filing of annual maintenance documents for the year 2024 shall be made not later than 30th November, 2023 through the TIRA Online Registration System (ORS) that is accessible through *https://ors.tira.go.tz/#/*. (Guideline on submission of documents is hereby attached).

The filing of documents shall be made upon payment of an application fee of Tshs. 25,000/= (Twenty-five thousand) and payment of Annual Fee of Tshs 750,000/- (Seven hundred fifty Thousand).

All Payments must be deposited through Government Electronic Payment Gateway (GePG), the control number shall be generated through TIRA Online Registration System (ORS).

An Insurance Broker shall furnish the Authority with the following documents;

- i. A letter from Tanzania Insurance Brokers Association (TIBA) confirming your active membership.
- ii. Your 3-5 years Business Plan and/or Strategic Plan signed by Board.
- iii. Implementation status of the Business Plan and/or Strategic Plan.
- iv. Fidelity Guarantee Cover note (Covering all members of staff) with Sum insured not

less than Tshs. 50m/-

- vi. Information on your current Principal Officer including;
 - a) Curriculum Vitae (CV);

- b) Professional certificates (Minimum advanced diploma in Insurance and experience for at least three years in insurance business;
- c) Copy of academic certificates verified by TCU/NACTVET (for foreign certificates);
- d) Professional certificates on Takaful from recognized institution;
- e) Employment contract/Copy of engagement letter attested by the intended candidate.
- f) Attested declaration on solvency and non-conviction in criminal offences; and
- g) Copy of NIDA/ Passport for non-citizen and work permit.
- vii. Particulars of Board Members of the Company. Your Board must have at least three members.
 - a) Curriculum Vitae (CV);
 - b) Attested declaration on solvency and non-conviction in criminal offences;
 - c) Copy of NIDA/passport of each director; and
 - d) Work permit (In case of foreigners).
- viii. List of all employees in the company together with their positions, National Identification Number (NIDA) and current citizenship.
- ix. Full details of Shariah Board advisors; at least three members.
- x. Particulars of Senior Management Staff.
 - a) Attested declaration on solvency and non-conviction in criminal offences;
 - b) Curriculum Vitae (CV);
 - c) Professional/Academic certificate verified by TCU/NACTVET (for foreign certificates); and
 - d) Copy of NIDA/ Passport for non-citizen and work permit for foreigners.
- xi. Particulars of your Shariah compliant Bankers including confirmation letter from banks specifying signatories.
- xii. Confirmation letter from Auditors.
- xiii. Confirmation letter from legal advisors.

With regard to SHARE CAPITAL, details must be furnished showing amount of actual Paid up Capital since the date of last application for renewal of registration. The minimum amount of paid up share capital to be maintained by an insurance broker shall be Tshs 19.8 million by the year ending 31st December 2023 (Regulation 18 (4)(b)).

For the purpose of FDR please attach a dully filled Minimum Capital Calculation Template that is available on TIRA website and Annexure 5 provided hereto.

The following additional particulars are to be furnished along with the filing for annual maintenance: -

- Documentary evidence in support of changes of Tanzania citizenship/shareholding in the company, (This should include proof from the Registrar of Companies and copy of Board resolution), in case of any changes(s) since your last renewal/registration application.
- ii. To this effect, brokers shall submit clearance letters with NIL Balance from insurers that they have been transacting with.
- iii. In case of outstanding balance, every broker will be required to submit a signed payment plan (agreement) entered between the broker and Insurers and submit the same together with renewal documents.

A statement whether any insurer has a service level agreement or Binder Agreement with you. If the answer is in the affirmative, please give full details and furnish copies of such agreements.

The deadline for filing annual maintenance documents is 30th November 2023. <u>A penalty amounting to TZS 40,000/= per day (Forty thousand shillings) would</u> <u>be imposed for late filing, incomplete submission and non-submission of annual</u> <u>maintenance documents.</u> Every registrant MUST pay all outstanding penalties which have been imposed by the Authority for the previous year.
