**ONE-MONTH EXTENSION PERIOD FOR ALL INSURANCE REGISTRANTS'**

Reference is made to the above captioned matter.

2. The Authority is extending the renewal period by one month for all its insurance registrants, including Reinsurance Companies, Insurance Companies, Reinsurance Brokers, Insurance Brokers, Insurance Agents, Bancassurance Agents, Insurance Digital Platforms, Loss Assessors and Adjustors, Private Investigators, and Actuarial firms.
3. All the aforementioned registrants are hereby required to upload all the necessary renewal documents as outlined on the Online Registration System (ORS) ([ors.tira.go.tz](http://ors.tira.go.tz)) for license maintenance of certificates issued not later than **31<sup>st</sup> December, 2023**.
4. Please be informed, that appropriate penalties and necessary regulatory measures shall be enforced for non-submission, overdue submission, or incomplete submission of documents required for annual maintenance by registrants who fail to comply with the set deadline.
